A Seminar on Intellectul Property Rights was organised by the college on Wednesday 26/04/2023 in ICT Classroom on the first floor at 11.00 am and the Speaker of the session was **Prof Sunil Sutar**. He gave a brief introduction on IPR and explained the various related terms such as copyrights, patents etc.

Introduction:- Intellectual property is a category of property that includes intangible creations of the human intellect and primarily encompasses copyrights, patents, and trademarks. It also includes other types of rights, such as trade secrets, publicity rights, moral rights, and rights against unfair competition. Artistic works like music and literature, as well as some discoveries, inventions, words, phrases, symbols, and designs, can all be protected as intellectual property.

The main purpose of intellectual property law is to encourage the creation of a wide variety of intellectual goods. Intellectual property rights refers to the general term for the assignment of property rights through patents, copyrights and trademarks. These property rights allow the holder to exercise a monopoly on using the item for a specified period.

Major Intellectual Property Copyright

Copyright is a legal term describing rights given to creators on their literary and artistic works. Related Rights. Rights granted by law to communicators of works to the public. Performers Performer's

Reproduction Rights. It mainly focuses on Re-broadcasting, Recording and Communicating to the Public of Broadcast. It has a duration of about 25 years.

Patent- is an exclusive right granted for an invention, which is a product or a process that provides a new way of doing something or offers a new technical solution to a problem. The limited monopoly right granted by the state enables an inventor to prohibit another person from manufacturing, using or selling the patented product or from using the patented process, without permission. The period of the patent is about 20 years.

Industrial Design- It is an article's ornamental or aesthetic aspect that must appeal to the eye. The design may consist of three-dimensional features, such as an article's shape or surface, or two-dimensional features, such as patterns, lines or colour.

Geographical Indication -is an indication which identifies goods as agricultural goods, natural goods or manufactured goods as originating or manufactured in the territory of the country, or a region or locality in that territory, where a given quality, reputation or other characteristic of such goods is essentially attributable to its geographical origin.

Layout Design It includes the layout of transistors and other circuit elements, including lead wires connecting such elements and expressed in any manner in a semiconductor integrated circuit (IC).

Trade secret Some inventions, data, and information cannot be protected by any of the available means of IPRs. Trade secrets can be inventions, ideas, survey methods, manufacturing processes, experiment results, chemical formulas, recipes, financial strategies, client databases etc.

The Protection of Plant Varieties and Farmers' Rights The Protection of Plant Variety and Farmers Rights Act, 2001 (PPVFR Act) is an Act of the Parliament of India that was enacted to provide for the establishment of an effective system for the protection of plant varieties, the rights of farmers and plant breeders, and to encourage the development and cultivation of new varieties of plants.
