COLLABORATION AGREEMENT

Exchange of Faculties and Student Skill Development.

Between

Shri Chhatrapati Shivaji Educational Society's Late Sau S R Abhang Memorial College of Arts and Commerce

And

Kamladevi Education Trust's Kamladevi College of Arts and Commerce

effective as of 19th SEPTEMBER, 2022 to establish an affiliation by and between Shri Chhatrapati Shivaji Educational Society's Late Sau S R Abhang Memorial College of Arts and Commerce, Ulhasnagar-04, hereinafter referred to as the FIRST PARTY.

And

Kamladevi Education Trust Kamladevi College of Arts and Commerce, Vitalwadi Kalyan (E) 421305, hereinafter referred to as the SECOND PARTY for the purpose of Exchange of Faculty and Student Skill Development.

The aforesaid institutions are hereinafter referred to individually as institute and collectively as institutions.

Preamble

WHEREAS, Shri Chhatrapati Shivaji Educational Society's Late Sau S R Abhang Memorial College of Arts and Commerce and, Kamladevi Education Trust Kamladevi College of Arts and Commerce, Vitalwadi Kalyan (E) 421305 has many areas of common interest, considerable advantage may be gained from their pursuit on a collaborative basis in the fields of academics, education and research.

NOW THEREFORE, Shri Chhatrapati Shivaji Educational Society's Late Sau S R Abhang Memorial College of Arts and Commerce and Kamladevi Education Trust Kamladevi College of Arts and Commerce, Vitalwadi Kalyan (E) 421305 have decided to enter into collaboration for the cooperation of the two institutions set out in the following Articles.

ARTICLE 1: OBJECT

Both Institutes agree to develop the following collaborative activities in the academic areas of mutual interest, on a basis of equality and reciprocity.

The two parties shall seek to promote:

1.1 Faculty/Staff Exchanges

- Organizing, participating in workshops, seminars, Faculty Development Programs, Interdisciplinary conferences, symposiums, and other types of academic discussions on mutually agreed upon topic
- 2. The exchange of academic materials and publications
- 3. finding solutions for common concerns of attendance and increasing student involvement and engagement, upgrading of teaching and research skills
- 4. Conducting study tours and joint consultancy work
- 5. Sharing of industry insights

A specific plan will be worked out for each activity; setting forth detailed arrangements for collaboration will be agreed.

1.2 Students Skill Development Programs

- 1. To guide and exchange information on educational programs,
- 2. To jointly organize short-term continuing education programs, Student Development Programs on topics of mutual interest,
- 3. To organize seminars jointly, conferences, or workshops on topics of mutual interest,
- 4. To give career guidance to students and provide training assistance for placements
- 5. To jointly organize job fairs for the benefit of the students

Terms and conditions for each visit or an assignment or such exchange, will be worked out between the institutes mutually.

Shri Chhatrapati Shivaji Educational Society's Late Sau S R Abhang Memorial College of Arts and Commerce and Kamladevi Education Trust Kamladevi College of Arts and Commerce, Vitalwadi Kalyan (E) 421305 agree that detailed terms and conditions that guide each activity identified above will be determined separately and agreed upon by both the institutions. These terms shall include a brief description of the proposed activity, financial arrangements, and person(s) responsible for its implementation.

ARTICLE 2: COORDINATION

Each institution shall appoint one member of its teaching faculty to coordinate the program on its behalf. Further, a program coordinator from each will periodically review and identify ways to strengthen cooperation between the two institutions.

ARTICLE 3: VALIDITY

The collaboration shall remain in force for a period of 2 years commencing from 1st September, 2022. Institutions may extend the term by written agreement signed by both after review.

ARTICLE 4: TERMINATION

Either institution may terminate the collaboration by giving written notice of one month in advance to the other institution. Once terminated, neither of the college will be responsible for any losses, financial or otherwise, which the other institutions may suffer. There will be No Financial Obligations on both the parties for any losses, compensation due to termination of this agreement. However, Both colleges will ensure that the provisions of this Collaboration Agreement shall continue to apply to all collaboration activities in progress until their completion. In case of breach of any provision, this agreement shall be treminated with immediate effect and No Formal notice will be given to either party.

ARTICLE 5: AMENDMENTS/MODIFICATIONS

This Agreement may be amended or modified by a written agreement signed by the representatives of both institutes.

ARTICLE 6: ADHERENCE TO LAWS

Participating faculties and staff involved in any activities under this Agreement must adhere to the law, rules and regulations of the institutions.

ARTICLE 7: LEGAL EFFECT

Nothing this Agreement shall be construed as creating any legal relationship between the institutes. This agreement is a statement of intent to foster genuine and mutually beneficial collaboration.

ARTICLE 8: DISPUTE RESOLUTION

In case, there is a dispute relating to any aspect of academic cooperation, The Principal of Shri Chhatrapati Shivaji Educational Society's Late Sau S R Abhang Memorial College of Arts & Commerce and The Principal of Kamladevi Education Trust Kamladevi College of Arts and Commerce, Vitalwadi Kalyan (E) 421305 will jointly resolve the dispute in a spirit of independence, mutual respect, and shared responsibility. Both the parties welcome the establishment of this Collaboration for cooperation and jointly agree to the provisions as set out above:
